<b>OUR COMMUNITY</b>	<p>A careful watch must be maintained on any further contraction of Post Office services: the loss of either PO would have a major impact on the Parish.</p> <p>Limited play facilities exist at the Wembury sports field and the Down Thomas Village Hall field. Continue discussions with local young people about improving skateboarding and other facilities such as a MUGA.</p> <p>Support the newly-formed Allotment Association.</p>	<p>WPC will monitor this situation</p> <p>WPC actively pursuing with SHDC &amp; DCC</p> <p>WPC have provided a grant, put in the planning application for the main shed &amp; polytunnel and are guarantors for the Allotment Association and WPC will continue to support them</p>
<b>OUR ENVIRONMENT</b>	<p>Be vigilant in maintaining the quality of existing footpaths and monitoring of improper use, e.g. by cyclists, and actively pursue footpath expansion – e.g. Down Thomas to Heybrook Bay.</p> <p>Maintain the beach liaison group.</p>	<p>WPC will assist as necessary</p> <p>Ongoing support by WPC</p>
